Literature Review

- Cognitive decline in dementia patients causes decreased Activities of Daily Living (ADLs) and increased healthcare costs, burdening patients and their caregivers (Pozzi et al.,
- Reduced rates of missing episodes among patients with dementia have been proven through home-based occupational therapy interventions (Lau et al., 2019).
- Caregivers feel more confident to care for their loved ones when they feel equipped with the proper coping strategies needed to manage their feeling of burden (Hui-Mei Chen et al., 2015).
- Through the opportunity of participating in home-based occupational therapy interventions, strong evidence shows optimized daily functioning for individuals with mild to moderate dementia (Ávila et al., 2018).

Learning Objectives

Project Description

Purpose: To advocate the need of home-based occupational therapy services for individuals with dementia to decrease caregiver burden

Business Plan: Developed a written business plan for the staff introducing the advantages of home-based occupational therapy and the information pertinent to expand services. The business plan includes:

- Reimbursement rates
- Medicare as a fee-for-service insurer
- Salary of an occupational therapist
- Mock budget of the cost of starting up services

Training Manual: A manual created for occupational therapists interested in working with the dementia population in a home-based setting. Information in the training manual include:

- Types of dementia
- Home-based evaluations and intervention strategies
- Employee expectations
- Supplies and equipment

Caregiver Resources: Caregiver handouts created to promote the safety of an individual living with dementia in their home and to decrease caregiver burden by increasing their knowledge of home safety. Handouts include:


- How to help your loved one safely get up from a fall

- Evaluation of knowledge and confidence levels


Business Plan: Staff Results

I am knowledgeable about the advantages of having occupational therapy services in a home-based setting for individuals with dementia




Training Manual: Staff Results
